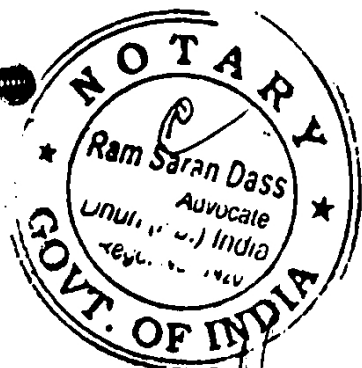
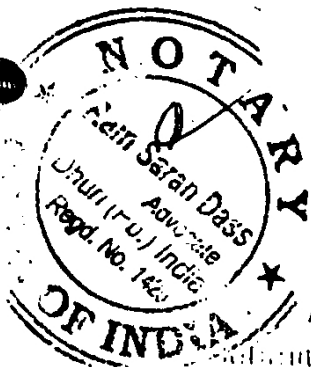
After considering carefully, the documents along with affidavits
submitted by the Management of your school and recommendations of
Joint Education Officer (Senior Secondary) and Director Education
(Senior Secondary) Punjab, Chandigarh, the N.O.C. is
issued by Govt. of Punjab as per conditions laid down as under:

In future, if it comes in notice on complaint/ inspection
that your application for N.O.C. on the basis of wrong
information and you having not adhered to the instructions
issued by the Govt. of Punjab issued from time to time and
the written conditions mentioned in affidavit have not been
complied by you, then in such circumstances, the N.O.C.
will be taken back at any time.

It will be compulsory to teach Punjab upto 10th standard in
your school and C.B.S.E., New Delhi will make it
compulsory to take examinations in Punjabi in such schools
and it is also mentioned that in case of non
implementations of this, N.O.C. will be taken back
immediately.

School Management will obey the notifications and Rules
made for Punjab State by the Education Department,
Punjab Govt. under the R.P.T. act 2009.

After securing affiliation with C.B.S.E. New Delhi, the
management of the school will be under obligation to pay
the salary and other allowances as per Govt. employees, to
the teaching staff and other teaching staff of the school. In

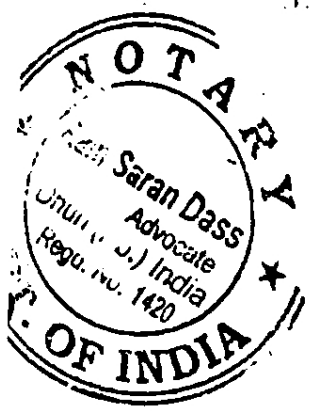

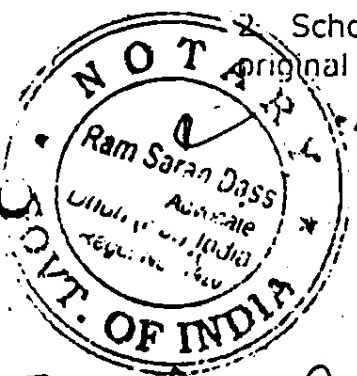
